3. The school shall be opened only in the approved medium and at the same place and no change of location shall be allowed for any reason. The same Governing Body to which permission has been granted to run the school shall run the school at the same place and under the same name.
4. This educational institution shall comply with all the government orders and rules in force and issued from time to time relating to educational institutions. The Karnataka Education Act 1983 (Karnataka Act No.:1:96) and the rules made there under shall be strictly followed.
5. Subject to the condition of providing school premises, space, building furniture, staff, financial facilities etc. The said educational institution shall not open more departments under any circumstances without the prior permission of the Government.
6. S: Id 175 P M C 95 Date :07/09/1998 Date : 29/12/1998 shall be permanently unaided. The Governing Body shall issue a consent letter of Rs. 50/ printed paper certified before a notary that it does not want any grant from the Government.
7. The Karnataka Private Educational Institutions (Recruitment, Service Conditions and Regulations of Employees of Private Aided Primary and Secondary Educational Institutions) Rules, 1999 shall strictly follow the rules.
8. Only the text books and examination procedures prescribed by the Department and the Government shall be adopted strictly.
9. Only trained and qualified teachers as per the department rules shall be employed.
10. Medical examination of students shall be conducted every year as per the rules.
11. The institution shall deposit the security deposit in the joint account of the District Deputy Director and the Governing Board to start the school.
12. The information about the opening of the school and the enrollment of students shall be informed to this office within three months of the registration of the school or the commencement of the academic year. If the school is not opened and any conditions are not met, the order shall be cancelled automatically.

The safety of the school building shall be checked and ensured against fire, storm and electrical accidents. A notice shall be posted in front of the school

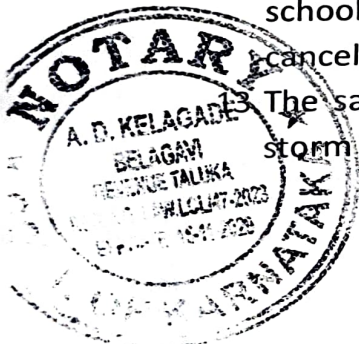

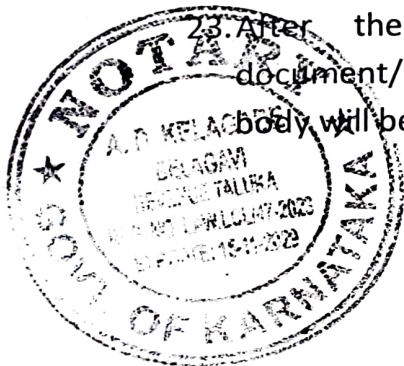

 18. The certificate regarding building safety shall be renewed from time to time by the competent authority and submitted to the concerned Deputy Director.
 19. If the documents uploaded online are not genuine, this order shall be cancelled automatically.
 20. The service security rules shall be followed in the school.
 21. At the time of granting the first recognition, the first recognition shall be granted only after verifying the authenticity of the original documents uploaded in the software such as the land transfer document, building safety certificate and fire safety certificate.
 22. Submit a proposal to this office for the first recognition within 03 months. The Deputy Director shall obtain the information of the Education Act and the check list of Government Order dated 30/09/2007 5 03 and on this basis, it shall be mandatory to obtain the first recognition within three months of the commencement of the school. If the recognition is not obtained within the specified period, the registration shall be cancelled automatically.
 23. After the school registration process is completed, the entire document/information in the application submitted online by the governing body will be made publicly available on the departmental website.
