Continuing in reference (4), if the school is started for the year 2022-23, a document has been submitted stating that 25 children are already available for classes 1 to 8. And since the said Board of Management has requested permission to start the school for the year 2022-23, the Honorable Commissioner has directed to check the compliance of all the conditions for starting the new school as per the rules and take necessary action to grant the said school registration for the year 2022-23.

Accordingly, as per reference (6), the Field Education Officer, Belgaum Rural, has submitted a document regarding the receipt of the building safety and fire safety certificate of the School. Therefore, including all these, the following order has been made.

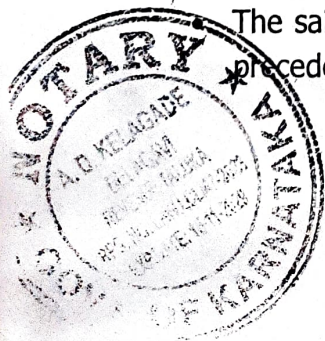
Order
